Contract on General Conditions for exhibiting in Belgrade Kids Fair

This Contract is drafted between the following Contracting Parties: the Organizer of Belgrade Kids fair and the Exhibitor, represented by authorized person - person whose data are entered into application for exhibition.

By signing this Contract, the Contracting Parties hereby accept all stipulated provisions:

Article 1 Organizers

Snar Group d.o.o, 61, Vidikovački venac and Sky Vision, 36, Dimitrija Avramovića Str., Belgrade, hereinafter referred to as (Kids Fair, abbreviated KF)

Article 2.

Application and confirmation of participation

Related to participation in this Fair, the Exhibitor concludes the Organizers the exhibition application in written form with. Based on received application, the Organizer shall allocate exhibition area. If the Fair's layout requires, KF may assign up to 10% larger or smaller area than applied for, which shall not be included in calculation.

Participation on the Fair may be cancel within 15 days upon registering application by KF, solely in written form.

Should the Exhibitor in written form suggests KF withdrawal of respective application not later than 30 days prior to Fair commencing, he is obliged to pay KF 50% of price for registered order exhibition area, exhibition fee, as well as other expenditures occurred by waiver on the part of the Exhibitor. Should the Exhibitor withdraws application for participation upon expiration of named deadline, i.e. less than 30 days prior to the Fair commencement, the Exhibitor is obliged to pay the Kids Fair 100% of price for registered exhibition area, exhibition fee and other expenditures related to waiver on the part of Exhibitor, within 30 days after application withdrawal. In the event of waiver of part of Exhibitor, the Kids fair reserves the right to freely disposes with assigned exhibition area, subject to prior lease. If special circumstances require so, KF reserves the right to revoke confirmed area and allocate the Exhibitor new area on new location under old or new conditions. Should reasonable reasons stipulate alternation of term and area of holding Fair, participation application is valid for new term as well. The Exhibitor has no right to cancel and submit requests more specifically has no right to claim damage reimbursement from KF, eventually caused by postponing term or area of maintenance.

Article 3.

Conditions of payment

For ordered services, KF shall furnish the Exhibitor with pro-forma invoice upon receipt of Fair application. Related to participation fee, the Exhibitor is obliged to pay 20% of the pro-forma invoice amount within 7 days, and the remaining 80% no later than 30 days prior to Fair commencement. Pro-forma invoice claims are to be submitted in written form within 3 days as of date on pro-forma invoice. Additional objections shall not be taken into consideration. For all entirely made advance payments until 15.06.2009., the Organizer gives 10% discount.

Article 4.

Special provisions

Right to approve any action on area of the Fair maintenance is sole discretion of the Organizer. It is not allowed to use electrical devices generating noise level over 55 dB on the stand. Music played in exhibition area is subject to the Law on Copyright and KF doesn't assume any material liability for obligations on this grounds. Any type of advertisement distracting other exhibitors is forbidden. All advertising actions outside of exhibition area of the Exhibitor require a special approval from KF. Organization of media conferences is to be executed solely through the Organizer. The Exhibitor may not consign allocate exhibitional area to any third party without obtaining approval from the Organizer. Any activity disturbing other exhibitors or visitors, and any political advertising are forbidden. Each Exhibitor must allow passage of the installations necessary for arranging stands of other exhibitors. The Exhibitor is obliged to conform with opening and closing hours of the Fair; in particularly, stand with exponents should be in function until manifestation closing. Fixing, hanging and gluing to the walls of the hall and other areas is forbidden. Should the stand of the Exhibitor is used for exhibition of other companies as well, and stuff of this company is present, they are liable to register as Co-exhibitors, paying mandatory exhibition fee, in this way obtaining the right to exhibit on the stand of the Exhibitor, registration in official catalogue of the Fair and option of leasing advertising area.

Indirect exhibitors: Should the stand leased by the Exhibitor will be used for exhibiting exponents of other company, not only brochures, prospects or similar publications, these companies have a status of indirect exhibitors. The Exhibitor is obliged to register all indirect exhibitors and to pay mandatory exhibition fee for each of them. Data on indirect exhibitor are not entered into the catalogue.

Article 5. Exhibitional area, unarranged

Unarranged area includes marked floor area in the hall. Area is marked by KF and the Exhibitor is obliged to conformed with it. Each section of used m2 exceeding reserved is calculated as one whole m2. Disassembling of exhibitional area may be initiated upon official closing of the Fair. The Exhibitor is obliged to return exhibitional area into prior condition in given term. Should the Exhibitor fails to do so, KF will disassemble it and store it on the expense of the Exhibitor.

Article 6. Other information

During preparation period, Fair maintenance and disassembling period, the Exhibitor is obliged to comply with the Labor Law, Fire Protection Law, and Law on Environment Protection and assumes full liability for eventual damage caused by incompliance with aforementioned laws. The term "Exhibitor" encompasses persons engaged in accordance with work order and on expenses of the exhibitor.

Article 7. Insurance

The Exhibitor insures its property. The Fair Organizer shall not be held liable for damage arising from missing, destruction or damage to the property of exhibitor during the Fair.

Other Fair services:

Exhibition passes - valid in period between the first day of Fair preparation to the last day of disassembling. Number of passes depends on the size of leased area (one pass on each 5 m2).

Sales regulation - In the event that the Exhibitor wants to sell exponents, he is obliged to prepare all necessary documentation required by all competent inspection services, as proscribed by the Law.

The Fair application has a legal effect of the contract. By sealing Fair application, the exhibitor confirms he has read it, he shall conform and agrees with the general conditions for exhibiting.

The Contracting Parties agree to resolve amicably all eventual disputes. Should such attempts fail and it is not possible to reach an agreement, court in Belgrade has a jurisdiction over this matter.

SUBMITTER OF THE FAIR APPLICATION

The Fair application is to be filled out in caps letters and sealed in thee copies. All copies are to be furnished to the Exhibitor who will confirm receipt, and return the Exhibitor one sealed copy. Note: All prices in the Fair application are VAT excluded.

Hereby we state familiarity with conditions of participation contained in the General conditions for exhibiting. The Organizers reserves the right to modify prices of lease of the exhibitional area and additional services.
